Arizona's solar industry went into this year's legislative session with an optimistic outlook and a conservative agenda. While we have a legislative agenda, our primary goal was to begin an educational process for the new Legislature and promote the formation of a Renewable Energy Caucus. However we soon found that there was a great deal of interest in energy, especially renewable energy, and that around twenty energy bills had been introduced. Not all of these bills were what the industry wanted or needed, but we found ourselves working to support the best and do what we could to make any legislation that had a chance of passing more effective.

One of the bills that we initiated was **HB2491 solar energy tax credit**; **application**. (Mason, Boone: Anderson, Nelson, Prezelski, Weiers J.)

This bill is a technical correction to clarify the commercial solar energy tax credit passed last session in HB2429. An interpretation by the Departments of Revenue and Commerce has prevented the tax credit being taken by third parties for the installation of solar energy systems at schools, state buildings and similar facilities. It clarifies the original intention of the commercial tax credit language to insure that third party financers can include system developers, contractors, etc. This will enable systems to be installed on state facilities, schools, nonprofits and other non-taxpaying entities using energy savings to pay for the systems.

The commercial tax credit is capped at \$1 million so there is not any additional impact on the budget. It is important for this language to be changed so that Arizona can realize the full economic development and air quality impact of last years legislation. Since this is the last week to hear House bills, this bill is being heard in two committees tomorrow. Wednesday March 28, 2007. It must make if through the Senate Finance Committee first, a committee that we bypassed year with the help of the Committee chair, now Sate Treasurer Dean Martin. This committee will be a difficult hearing since it has three members who consistently have voted against solar energy legislation, Senators Cheuvront, Gould and Gorman. If you live in their districts, we encourage you to call and to email them and ask them to support this legislation. In fact, we also could use your help encouraging other members of the committee to vote to give this legislation a "do pass recommendation". All of the others voted for the tax credit bill last year, but we need to be sure that we have the votes of all committee members, especially Senator Leff. She supported the bill last year, but a few phone calls from constituents for insurance would be a good idea.

One of the bills that cropped up and has taken life is **HB2593 homeowners associations; solar panels.** Rep. Chad Campbell, of District 14, introduced this legislation and we have been working with him to make this bill more effective than its introduced version. This bill makes changes to Arizona's solar rights statute ARS 33-439. This long-standing statute supports the rights of homeowners to install solar energy devices, yet has been ignored since its passage in 1979, by many homeowners associations. The Arizona Solar Energy Industries Association supports this legislation with the adoption of the Flake amendment.

This bill allows HOA's to adopt reasonable rules for the placement of a solar energy device if those rules do not impair the functioning of the device, restrict its

use, or adversely affect the cost or efficiency of the device. The amendment also contains some strong legislative intent language to make it very clear that the Arizona Legislature supports the private property rights of homeowners to install solar energy devices.

The Arizona Solar Energy Industries Association (AriSEIA) has worked to assist HOA's in the adoption of standards that will lead to aesthetically installed solar energy systems, yet a great many associations still arbitrarily deny applications from homeowners or place onerous restrictions in their way. We have also battled the HOA's in the courts in the Garden Lakes case and won an important victory. Rising costs and energy supply are serious concerns of Arizona homeowners. Greater use of solar energy by Arizona homeowners will lead to greater energy independence for our state, the creation of jobs, and cleaner air for our communities.

This bill will be before the Senate Government Committee on Thursday afternoon and calls from constituents will help get his bill past committee. Please ask your Senator to vote in favor of **HB2593 homeowners associations; solar panels** and the Flake amendment. The Flake amendment will add clarification and add the intent language.
