## We need your help! ! !

HB 2374 solar energy equipment: taxation has passed the Appropriations Committee and is on it's way to the Rules Committee. After Rules, it's next stop is the floor of the House for a vote. Please don't underestimate the power of your phone calls, faxes and e-mails to your Legislators. If you have not already done so, please call today!

House Bill 2374, sponsored by Rep. Lucy Mason, will increase the residential tax credit for solar energy devices to \$5000 per residence from the current \$1000 level, and increase the single residence credit for photovoltaic systems from \$1000 maximum or 25 percent of cost to \$3000 maximum or 15 percent of cost. It will also establish a commercial tax credit of 25% of the system cost with a \$5000 maximum credit per system for businesses installing solar.

Please tell your Representatives in the House that you would like them to support HB2374 and work actively for it's passage. Tell them that they should support the bill for the following reasons:

- Creates good paying jobs
- cleaner air
- reduce our dependence or imported energy
- helps Arizona's economy
- more disposable income for Arizona families
